

Supplementary Regulations

- 1. The Sporting Car Club of Norfolk Ltd. (SCCoN) will promote a Table Top Rally running throughout May 2020.
- 2. The event is open to anyone; membership of the organising club is not required.
- 3. There is no maximum entry for the event. Entries open on publication of these regulations.
- The event will take place on a table at your convenience. All documentation will be available from the SCCoN website. Route Cards will be available from 8:00 am on Friday 1st May 2020. Final date for submission of Answer Forms will be 6:00 pm on Sunday 31st May 2020.
- 5. The latest revision of O.S. Landranger map 133 will have a map legend reading 'Revised August 2018', the navigation will also be checked against the previous revision with a map legend reading 'Revised September 2013' and possibly the previous revision Edition D3 'Revised 2013'.
- Please use the Online Entry Form (only required if you intend to submit Answer Forms and want to be classified in the results) and there is NO Entry Fee. Entries will be accepted from individuals or teams. Entries Secretary: David Bell. Tel 01603 720 871. Email percy@sccon.co.uk.
- 7. Results will be published as soon as possible following the end of the event.
- 8. Classes: Beginner, Novice and Expert. Each class will have a different route with its own route check questions and answers. Beginner navigation will be at a similar level to that handed out to Novices on a SCCoN 12 Car. Novice navigation will be at a similar level to that handed out to Experts on a KLDMC 12 Car. Expert navigation is intended to be challenging.
- 9. The event will be continuous with 5 sections. Each section will have a start reference and there will be a link section between the end of one section and the start of the next section. As on a 12 car, unless specifically indicated, no road can be used more than once. Each route card will indicate which classification of roads will be used on that section. CRO coloured roads only for navigation and route. CAR consider all roads for navigation but CRO for route. WUW consider all roads for navigation and route.
- 10. Each section will have 10 route checks. Route checks will be in the form of the answer to a simple question. Please submit one Answer Form per section. The sections do not have to be done in order but be aware that the route of another section may affect the route for the current section. Multiple submission of Answer Forms for a section is fine, the last submission received before the closing date will be the one to be marked.
- 11. Penalties:

a.	No attempt at a section	10 marks
b.	Missing or incorrect route check	1 mark
C.	Each hint requested	2 marks

- 12. Further Information.
 - a. All the documentation needed Registration Form, Route Cards, Answer Forms will be available on the club website.
 - b. All sections count towards the event result.
 - c. General queries can be emailed and will be answered but route specific queries will be answered with a 'no comment'.

- d. Route check answers may well change as answers are submitted; results will remain provisional for 7 days after they have been published.
- e. It is all meant as a bit of light relief, do not be put off if you have absolutely no idea on a particular section, all navigation is based on a very small set of basics, the hints available should be enough for the penny to drop. As a rule of thumb on any section expect the time spent to be split 25% solving the puzzle, 25% plotting the route and 50% answering the route check questions.
- f. It is not a race, you have a month, do not worry if you inadvertently submit a blank answer form, use the Comments box if necessary and the results will be based on the last Answer Forms submitted before the closing date.
